Membership Criteria

- Adult Members: aged 18 and over
 - Junior Members: aged 17 and under
 - Student Members: who are young adults between the ages of 18 – 23 in full time education
 - Concessionary Members: who are past the national retirement age and are in receipt of the State Pension
 - Family Members: Two adults and all the children seventeen and under who are the lawful responsibility of those adults, living at the same address, provided that those children are only eligible for Junior membership.
 - Short Term Membership: People who do not permanently live in West Mersea or East Mersea or the neighbourhood can be members for a period not exceeding 3 calendar months. A period of 24 hours must elapse after payment of the fee and the MICA facilities being used. This Membership is limited to one occasion in any 12-month period.
 - Temporary Membership: People who do not permanently live in West Mersea or East Mersea or the neighbourhood can be Temporary Members for a period not exceeding 14 days. A period of 24 hours must elapse after payment of the fee and the MICA facilities being used. This Membership Class is limited to one occasion in any 6-month period.
